

Qualification & Experience	Diploma/degree in leather and footwear technology and 5 years of post qualification experience in the relevant field.

Job Description	The functions of the consultant shall include survey of livelihood opportunities through leather based activities within project area, analyse the shortcomings of existing activities and prepare action plan necessary to mitigate these shortfalls. He shall conduct site inspection for raw material, identify established business sites, conduct market studies and establish forward and backward links for the development of leather cluster. The livelihood sub-project proposal shall be prepared by the consultant in collaboration with district team and prepare its roll out strategy.

Job Profile

- Conduct leather based livelihoods need assessment for the members of community institutions in Dausa district; develop the project plan for the leather cluster emphasizing its objectives and implementation plan based on the assessment.
- Identify and analyze the key issues/strategies/activities related to leather activities i.e. existing scenario, current shortfalls, livelihood opportunities with sustainability at the field level and put forth them with the project persons concerned for the necessary actions.
- Identify skills and training gaps for promoting the leather based livelihood activities, make recommendations and draw action plan to bridge the gaps and develop the roadmap to create a support mechanism for the effective implementation.
- Suggest and design suitable skill enhancing interventions for the identified members of the community institutions. Identify and co-ordinate with the institutions for the implementation of the interventions in the project district.
- The consultant would work in collaboration with the officer in charge for the self employment generation activities.
- Any related work assigned by the State Mission Director.

Reporting

- The reporting authority for the incumbent would be the Project Director (LPs & SHGs), RGAVP.

Qualification and Experience

- Diploma/degree in leather/footwear technology.
- Should have knowledge about leather products & Accessories Designing.
- At least 5 years of post qualification experience in Livelihood Investment, Income generation through leather activities, etc. and development of leather cluster.
- Experience of working with the State/Central Government would be an added advantage.
